*Required for floodplains associated with Shorelines of the State, like the Deschutes River, to prove that your structure will not displace more than 10 cubic yards of floodwater in the event of a base flood. See handout for more details on the required study.

All residences require the submission of three elevation certificates. Non-residential structures may also require an elevation certificate. A licensed land surveyor must complete the elevation certificate in zones with base flood elevations. A landowner or owner's representative shall complete the elevation certificate **before building permit plan review commences. The second certificate is required prior to the framing inspection. The third certificate is required after the structure is completed and before occupancy or final approval. The elevation certificate ensures the structure is elevated 1-foot above the Base Flood Elevation as required by Tumwater Municipal Code. If your structure is not built 1-foot above the BFE, flood insurance rates will be substantially higher. See FEMA Form 086-0-33 for more information.
