- A. By a cash deposit or corporate surety bond in the sum of five hundred dollars as indemnity for any damage which the City may sustain by reason of damage or injury to any highway, street or alley, sidewalk, or other property of the City, which may be caused by or be incidental to the removal of any building over, along or across any street in the city and to indemnify the City against any claim of damages to persons or private property;
- B. By a public liability insurance policy providing one hundred thousand dollars to satisfy any claim by private individuals, firms or corporations arising out of, caused by or incidental to the moving of any building over, along or across any street in the city; and
- C. By a cash deposit or corporate surety performance bond in the sum of five hundred dollars, conditioned upon the permittee, within six months from the date of the issuance of such permit:
